## Abstracts – Call to Artists

### ABSTRACTS

ArtServe introduces colors, shapes and forms to the JM Family Enterprises Gallery in the first Abstract exhibition to be held at ArtServe. Abstract art is now generally understood to mean art that does not depict objects in the natural world, but instead uses color and form in a non-representational way.

### ELEGIBILITY

Abstracts is open to **ArtServe members** as well as **nonmembers and students**. All artwork entered must reflect "non-figurative art," "non-objective art," and "non-representational art".

### MEDIA FOR GALLERY SHOW

**Open theme, open media.** Artwork of any media will be accepted. The Curator has final acceptance of content. Selection for this show will be based upon space availability.

### ABOUT THE JUDGE

Frederick Schmid, currently resides in Ojai, California. Schmid started in the art field 40 years ago as Curator at the University Museum, Southern Illinois University after his graduate work in anthropology and primitive art. Since then, Frederick has served as museum director of the Joslyn Art Museum, Omaha; Assistant Director, Museum Programs at the Smithsonian Institution; Counsel at the Armand Hammer Museum of Art, Los Angeles, and Vice President, Kansas City Art Institute. At the present time, Frederick works on several projects to market and publish artists and artists' groups.

### ENTRY/FEES

Abstracts will be open to members of ArtServe as well as non-members & students. Up to **THREE** 2D or 3D pieces of artwork or up to **TEN** pieces of jewelry may be entered. Artists may enter extra pieces at an additional cost of \$5 per piece. 2D artwork must be wired for hanging and may not exceed 60" wide x 60" tall.

Jewelry must be tagged prior to intake with a description of each piece and the 25% gallery mark up retail price already on the tag. A 25% mark-up on all artwork will apply.

**Member Fee – FREE (2D & 3D - 3 pieces of artwork only!)  
(Jewelry – 10 pieces only)**

**Non-member Fee - \$40**

**Student Fee - \$25**

### PRESS PHOTOGRAPHS

Participants may email up to three photographs (300 DPI) of the artwork they plan to enter into the show to [byrons@artserve.org](mailto:byrons@artserve.org). Deadline is April 9, 2008. Photographs may be selected to be printed for promotional purposes. By submitting these photographs the artist acknowledges that the images will be used for publicity.
